TERMS AND CONDITIONS

1. MALAYA Balikbayan Box agrees to receive, ship, release from the Philippines Bureau of Customs, and deliver to whomever the SENDER desires in the Philippines (Door to Door), the latter's personal effects.
2. The SENDER is responsible for packing his/her personal effects. MALAYA Balikbayan Box shall therefore not be held liable for any breakage, damage, or spoilage that may occur during handling or shipping.
3. The SENDER agrees that in the event of loss of said personal effects, MALAYA Balikbayan Box shall be liable only to the extent officially declared by the former. However, such liability shall not exceed the amount of €250. Should the value exceed this amount, the SENDER may insure the excess amount with the company by paying the premium.
4. The SENDER shall not send banned, prohibited, or regulated drugs, firearms, explosives, ammunition, combustible, or inflammable materials. In relation hereto, the SENDER shall complete an official declaration of the contents of said personal property. In case of misdeclaration and discovery of banned or prohibited contents, MALAYA Balikbayan Box reserves the right to leave all the SENDER's personal effects with the Philippine Bureau of Customs, which may result in confiscation by the Philippine Government. This action incurs no liability against the SENDER, but does not prejudice any case filed against the SENDER or his/her CONSIGNEE.
5. MALAYA Balikbayan Box may, at its sole discretion, open and inspect the Balikbayan Box without notice. Governmental authorities may also open and inspect any shipment at any time.
6. If dangerous goods or items are discovered inside the Balikbayan Box and cause damage or contamination to any property, the SENDER of said box is solely responsible and will reimburse and indemnify MALAYA Balikbayan Box for any and all costs, fees, and expenses incurred in connection with the cleanup of such damage and contamination.
7. MALAYA Balikbayan Box will not be liable or responsible for loss, damage, or delay caused by events beyond its control (natural disasters, strikes, acts of terrorism, war or civil strife, disruption or failure of communication and information systems, criminal acts of any person or entities).
8. The box dimensions are 72 cm x 45 cm x 60 cm and shall not be exceeded or deformed due to overpacking, otherwise additional charges will apply.
9. In consideration of the service, the SENDER must pay the amount according to the attached price list. Only fully paid cargo will be delivered to the CONSIGNEE. Failure to pay the required shipping fee on time will result in additional warehousing fees.
10. This agreement shall take effect upon signing hereof and shall cease upon fulfillment of the company's delivery of the SENDER's personal effects to the CONSIGNEE.
